# European Week for Waste Reduction announces finalists of the EWWR awards

On 7<sup>th</sup> of March 2016, the EWWR Awards Jury came together in Brussels to determine the finalists and winners of the [EWWR 2015 Awards](#).

The annual **EWWR Awards ceremony** is an event created to reward the most outstanding actions carried out in each EWWR edition. Each year, Coordinators, Action Developers and anyone interested in the EWWR gather during one evening to celebrate the EWWR and its participants. A Jury of European professionals working in the environmental sector selects finalists and winners amongst all the many inspiring EWWR actions!

Hosted by [ACR+](#), the leading EWWR project partner, the Jury had a fruitful discussion about the fantastic actions submitted for the EWWR 2015 Awards. For all six [categories of Action Developers](#), three actions have been chosen as finalists, according to the [selection criteria](#). The winners will then be revealed during the Awards ceremony on 11<sup>th</sup> of May 2016 in Brussels.

### The EWWR 2015 Awards finalists

Out of more than 90 actions that had been submitted by EWWR Coordinators to run for the EWWR Awards, three actions per category of Action Developers have been chosen as finalists:

#### Administrations/ Public Authorities:

- *A Tiana reduïm els residus* (In Tiana we reduce waste), implemented by the Ajuntament de Tiana
- *The Gift of Waste*, implemented by North London Waste Authority
- *The near community ReTurn reuse and recycling center*, implemented by VA SYD

#### Associations/NGOs:

- *LuogoComune* (SharingPlaces), implemented by Il Formicaio Aps
- *Reducing waste from perishable food products*, implemented by Banco de Alimentos de Bizkaia

## The EWWR Awards Jury 2016
